Dear fellow members of ICC,

Here are some news to prepare for the meetings of the International Corrosion Council, during the 17^{th} ICC in Las Vegas, October 6-10, 2008:

1. There will be two meetings of the International Corrosion Council, during the Congress:

The first one will be held on Sunday October 5 or on Monday 6, from 5 to 7 pm. The exact time will be fixed by the organising committee and should appear on the conference website.

The proposed agenda is:
