Dear fellow members of ICC,

The 18th International Corrosion Congress is approaching. As you know it is being organized by the Australasian Corrosion Association (ACA) and will take place in Perth, Australia on November 20-24, 2011. The Final Programme can be obtained at http://www.18iccperth2011.com.

Here are some news for the meetings of the International Corrosion Council (ICC) during the Congress.

1. **ICC** Meetings

Constitution and Bye-Laws of ICC can be found at http://www.icc-net.org/ICC Bylaws.html. All Council members, including new-appointed members, are invited to attend. After confirmation of the Membership at the beginning of the 1st meeting (item 2 of Agenda (Annex 1)), the new members are entitled to vote on the issues dealt with.

There will be two meetings of the ICC during the Congress:

The first one will be held on Sunday 20th November 2011.

2. Appointment of proxy

According to the ICC Bye-laws, clause 9.2 "A quorum shall consist of more than 50% of the member countries, either attending or represented by proxies". To fulfill this requirement it is important that as many Council members as possible attend or appoint a proxy. For convenience a form is enclosed (Annex 2) by which a proxy can be appointed. If you don't have anybody else in mind, you may appoint someone in the Executive Committee to be your proxy: T. Tsuru (e-mail: tsuru@mtl.titech.ac.jp), M. Morcillo (e-mail: morcillo@cenim.csic.es), C. Arroyave (e-mail: vicerrector.cti@uan.edu.co), A. Pourbaix (e-mail: apourbai@ulb.ac.be). They are all expected to attend. Appointment of proxy should be sent by mail (ordinary or electronic) or handed over to the Chairman before or at the beginning of the Council meeting. I hope, however, that it will be possible for you to be personally present.

3. Minutes of the Council meetings held at the 17th ICC in Las Vegas (Annex 3)

4. <u>ICC Membership</u>

The 1st ICC Vice Chairman (M. Morcillo) and the ICC webmaster (B. Chico) have organized re-examination of previous Membership and appointment of new members. The result of the work can be seen in the Provisional Membership List enclosed (**Annex 4**). As mentioned, confirmation of the new Membership will be dealt with at the beginning of the Council meeting.

5. 18th ICC Young Researchers Travel Award

The Chairman of the ICC received seven applications for young researchers travel award. The ICC Executive Committee selected four of them after examining their curriculum vitae and quality of application:

 P. Montoya (Colombia)
 J. Sudagar (China)

The grant of 1,000 € will be given to them during the ICC Conference in Perth.

6. <u>Election of Vice Chairman for the period 2011-2014</u>

A nomination committee composed by Oladis Troconis de Rincón (chairwoman, Venezuela), David J. Young (Australia), Damien Feron (France) and Louis Pretorius (SouthAfrica), proposed two candidates for the vice-chaipersons.

- Carlos Arroyave (Colombia, presently 2nd chairman of ICC)
- Panayota Vassiliou (Greece).

According to the Bye-laws, the Council members were asked to make additional nominations by petition. However, no additional nominations were received in the ICC Secretary and therefore,

these two ICC members will be the only two eligible candidates.

On September 15th a ballot for the election was sent by D. de la Fuente (ICC Secretary-Treasurer),

Annex 5, as well as curriculum vitae of the candidates.

7. <u>Bids for the venue of the 19th International Corrosion Congress</u>

On April 24th, 2011, the bidding period for hosting the 19^{th} ICC Congress to be held in 2014 was

closed.

At their regular meetings during the Congress (November 20th and 22nd), after discussion and voting, the Council shall elect the host country for the next Congress among the three invitations submitted.

8. <u>Establishment and Presentation of Awards</u>

The Executive Committee has selected two recipients of the Marcel Pourbaix Award for 2011. The names of the recipients will be announced at the Council meeting on 22 November and again the medallions will be presented at the banquet.

I am hoping to see many Council members in Perth. Your attendance, as always, is important for promotion of co-operation and friendship between corrosion scientists and engineers in different countries. It is the one opportunity in each three-year cycle when many Council members may meet and debate the important issues concerning our subject. May I suggest that you bring this Newsletter with you. Likewise do not forget your travel arrangements, including a visa for most people!

3. Approval of agenda

The agenda is approved.

4. Approval of the minutes of the Council meetings held at the 16th ICC in Beijing

The minutes are on the ICC website (http://icc-net.org). The minutes are approved.

5. Collection of ballots for the election for first and second vice-chairpersons of ICC for 2008 to 2011.

The ballots are collected. Three tellers are designated.

6. Overview of the coming 17th ICC congress, by the local organising committee

On October 5, the attendance is about 280 and more are expected to register during the congress. The CD with the proceedings will not be available at the congress and will be sent immediately after. The organising committee feels the scientific level is very good.

Visas were delayed or refused to at least five *bona fide* applicants. The Executive Committee proposes that this be mentioned in the opening ceremony and appear on the ICC website. The EC also requires that the proceedings be sent free to those applicants and that their presentations be made by the session chairman or by a member of the Executive Committee. The members of the Council and the Organising Committee agree on these proposals.

The chairman asks to be informed of all other applicants who applied for a visas in due time and did not receive one.

7. ICC activity report:

The efforts and achievements of ICC in terms of international cooperation

 Thanks to the generosity of the GAMRY company and on the recommendation of ICC, two sets of electrochemical instruments were donated to research teams (one in the Philippines and the other in Egypt) that demonstrated their motivation and involvment in corrosion studies and that have little financial resources. ICC expresses its gratitude to Pete Peterson (GAMRY) for making this action possible.

- ICC is offering two awards of maximum 1.000 euro to help young researchers to attend ICC congresses. Only one valid application was received for Las Vegas, and was granted.
- ICC provided a financial assistance to a limited numbers of authors from countries with a difficult economy to contribute to a special session at the 17th ICC on « Global approach to current and future corrosion problems worldwide » (see our Newsletter nr.9). Support was granted to four applicants. Unfortunately, one could finally not attend.
- At the last Council meeting in Beijing, it was proposed that ICC members who feel that their government is not aware enough of corrosion problems and prevention should contact the ICC chairman for help, for example through an official letter from ICC with arguments and proposals, with indication of the local expertise resources. Such an action was initiated with Indonesia, but more refinements appear necessary before final implementation.
- ICC members are encouraged to use ICC and the international corrosion community to exchange young corrosion researchers, to exchange all types of scientific and technical information and to provide, when possible, second-hand or less recent instrumentation etc.

The representation of all countries within ICC

- All countries should be represented at ICC. The role of ICC members is not just to vote for the next congress venue: they should have a detailed knowledge of the corrosion scene in their own country: local problems, sources of information and expertise, resources, major needs (equipment, people, information...) etc. To achieve this, it is recommended that the two members of a given country belong to two different organisations.
- Manuel Morcillo has updated the list on the website and also in directory, with biographical data and photographs.

The 17th ICC congress

- ICC organises a joint ICC/WCO session at this 17th ICC congress on « Global approach to current and future corrosion problems worldwide », under the auspices of ICC. The intention is to describe some specific aspects of corrosion prevention in low economy countries with the hope that international programmes will contribute to reduce the gap between rich and poor countries.

8. ICC financial report

The income comes essentially from the levy of the ICC congress. The expenses are limited to the travel costs of the secretary-treasurer for the meetings of the Executive Committee and to the awards (one young researcher travel award and four awards for the ICC/WCO special session).

The financial report shows a small increase of the credits of ICC since before the 16th congress in Beijing.

It is expected that the income from the 17th congress in 2008 will be lower than for the 16th congress. Some expenses for the transfer of the webmaster are foreseen.

9. Presentation of bids for the venue of the 18th International Corrosion Congress

The bid from Canada was withdrawn. Each bidder is asked to answer questions from the Council on delivery of visas, costs, accomodation, dates, expected number of participants etc.

Presentations were made for:

- Australia (Perth), by the Australasian Corrosion Association
- Hungary (Budapest), by the Hungarian Corrosion Society HUNKOR
- Indonesia (Bali), by the Indonesian Corrosion Association INDOCOR

Colombia (the Asociación Colombiana de Ingenerios de Corrosion) introduced a valid bid, but nobody was at the meeting to present details. The vote on October 7 will however consider this bid as well.

10. Collaboration with the World Corrosion Organisation WCO

Since the last ICC congress in Beijing, a World Corrosion Organisation WCO was installed. The goals announced by WCO are:

- raise public awareness on corrosion and corrosion control
- identify world best practises in corrosion management
- facilitate the provision of corrosion control expertise to governments, industries and communities
- normalise corrosion related standard worldwide.

Some of these goals overlap with those of ICC.

The Executive Committee of ICC examined the ICC/WCO relationship in detail and considers that each have their own specificities. One specificity of ICC is to promote cooperation and friendship among corrosionists all over the world and to foster the exchange of results and experience. Another one is to insist on cooperation with countries with difficult economy to decrease their dependence on rich countries.

ICC invited WCO to actively contribute to a session organised by ICC at the 17th congress on "Global

approach to current and future corrosion problems worldwide", where such issues will be addressed.

The members of the Council support these views and actions.

11. ICC Awards

One young researcher travel awards was awarded to a young researcher from Tbilissi, Georgia. The

2008 « Marcel Pourbaix award for promotion of international collaboration » will be presented at the

conference dinner to Dr. Vladimir Kucera, for the international cooperation he set on atmospheric

corrosion projects, to which he associated researchers from a large number of countries all over

the world, and for his efforts and successes in reducing the SO₂ pollution levels, for the benefit of

the society.

12. Results of the election of vice-chairpersons

Manuel Morcillo (Spain) becomes first vice-chairman and Carlos Arroyave (Colombia) becomes

second vice-chairman.

13. Designation of a secretary- treasurer for the period 2008 to 2014

Patrik Schmuki, who skilfully served for more than 7 years, wants to be discharged. The new

secretary-treasurer is Daniel de la Fuente (Spain), for two periods of 3 years. The Council approves.

The website of ICC must be improved, with more informations and a better visibility and access.

The website should also be adapted to serve as a mean of communication between members of ICC

and with the Executive Committee.

14. Other business

Suggestions are made that ICC sponsors meetings organised in different countries and that ICC works

to increase interest for the studies in Materials Science and Corrosion, and also to introduce

corrosion courses or conferences in other disciplines (architecture, mechanical engineering etc.).

2. Vote on the venue of the 18th ICC congress in 2011

A two-turns vote gives a majority of votes for Perth, Australia for the 18th ICC congress in 2011. The

other bidders are thanked for their excellent presentations, and Australia is congratulated for its

success. The Colombians members attending the meeting commented that they have received an

email from Prof. Carlos Arroyave who apologized to be absent in the Congress to bid the candidature

of Colombia

The EC asks the organisers of the 18th ICC to maintain a better contact with ICC and to prepare

earlier than was the case in 2008 and to closely follow the ICC rules on calendar, exchanges of

projects etc.

3. ICC membership

The situation after Beijing Congress (2005) was the following:

• The list was not updated from long time.

• Many Appointing Bodies were unknown.

• The e-mails were known only from a limited number of members.

• The figures were:

o Countries: 70

o Members: 129, However only in 58 of them the status was valid. For the rest the

membership period had been expired.

A great effort has been made to update the ICC membership list:

• To obtain good e-mail addresses.

• To obtain renomination of members with the membership period expired.

• To obtain nominations for new members.

• To know the addresses of the Appointing Bodies.

Now, the figures are the following:

o Countries: 64

o Members: 117

- An administrative questionnaire and a biographical form were created and sent to the

members for completing. With the answers obtained (67%), a Directory of ICC members

has been elaborated with the photograph of the member included. As you know this

Directory has been sent to all the ICC members and will be inserted in the ICC web page.

Countries:

• Countries which had members at the ICC, but not now because of the expiration period

of the members are the following:

o Out of the ICC from 2002: Hong-Kong, Iran, Morocco, Serbia, Sri Lanka, Zimbabwe

- o Out of the ICC from 2005: Poland, Russia.
- We have tried unsucessfully to get nominations from these countries. Also with other countries like Slovenia, Kazakhstan and United Arab Emirates.
- However, we have obtained nominations from new countries as Algeria and Burkina
 Fasso and in short time we will have nominations from Denmark and Luxembourg.
- We must urge those countries who only had a single representative to appoint a second, as permitted by the ICC by-laws
- A strong call is made for all members to check the membership list and to send to the Secretary of ICC a note of any change in their personal details, address, contact numbers, etc.
- The EC asks every member of ICC to suggest names of possible delegates for countries that are not yet represented in ICC and for countries that have only one delegate.

4. Activities of ICC

The activity report for 2005-2008 is summarized again for the members who were not present on October 5, and is approved.

The future chairman Tooru Tsuru gives an outline of his plans for the future.
