Call for supporting the attendance of senior corrosionists

The EC of the ICC decided to open a call oriented to reimburse the registration fees of one or two recognized senior corrosionists who are currently retired with a proved participation in at least three previous ICC congresses. Applications will be

received by the EC, until Monday 14 of August, 2017. They will be evaluated for the selection and final decision.

Call for the 20th ICC Poster Award

As in previous events, the ICC will give an award to the best poster presented in the 20th ICC Congress. A commission of recognized senior researchers will be the jury.

Marcel Pourbaix Award

It is with great pleasure that the EC of the ICC announces that the winner of the Marcel Pourbaix Award 2017, by unanimous decision is Professor Christofer Leygraf, from the Royal Institute of Technology - KTH, Stockholm, Sweden.

General Assembly

The EC of the ICC invites all the current national delegates of the ICC to attend and actively participate in the General Assembly to be hold next September, in the framework of the 20th ICC Congress. Scheduled on Sunday 3 of September 2017 from 16:00 to 18:00 CET (Part 1), and Tuesday 5 of September 2017 from 17:00 to 19:00 CET (Part 2).

Renewal and nomination of new delegates

The EC of the ICC also wants to invite all the former delegates, national nominations bodies and all the community in general, to nominate new names for continuing or stating the integration of the countries that are not formally represented at the ICC. Nominations and decisions will be took in the coming General Assembly.

Election of Vice-Presidents 2017 - 2020

One of the relevant points of the upcoming General Assembly will be the election of the new Officers of the ICC. All the current national delegates have received the report concerning the followed procedure, the names of the candidates, and the instructions for voting or delegating on another member during the General Assembly.

Venue for the 21st ICC congress

Two candidates have applied Canada and Brazil. Both of them are in full agreement with the bylaws and must be considered for the election of the next venue of the ICC Congress in 2020. Final selection will be done by decision of the national delegates during the upcoming General Assembly.

Amends to the by-laws

Taking into consideration the enormous changes that are happening along these decades, some of the issues included in the bylaws have been discussed in different opportunities. Consequently the EC has prepared a proposal of emend to be submitted in the upcoming General Assembly. A draft of the proposed changes will be sent to the National Delegates in the following weeks for consideration, contributions, and enrichment.
